

## **INFORMATION NOTE CONCERNING THE PROCESSING OF PERSONAL DATA FOR REGISTRATION AND ACCESS TO THE "Photo Gallery" MENU**

### **Personal data operator**

KMG Rompetrol (the Company), part of the KMG International Group, with headquarters in Piata Presei Libere 3-5, 5th floor, Bucharest, registered with the Trade Registry under no. J40/9817/2010, legally represented by Zhanibek Nugertayev and Aizhan Dykanbayeva as proxies of the sole director, is required to process and store your personal data that you have provided us in accordance with the applicable law

### **The applicable law**

- Regulation (EU) 679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (RGPD),

**Personal Data (DCP)** - name, surname, email address, IP address

**The purposes of processing** - DCP are processed by the Company to provide you with the right of access to the contents of the "Photo Gallery" menu as a result of your registration via the [www.kmginternational.com](http://www.kmginternational.com) website to transmit your request to our IT service provider WebStyler SRL and for archiving DCP and downloaded materials from the "Photo Gallery" menu.

**Duration for data processing** - The DCP storage period will be during your use of the content of the "Photo Gallery" menu at [www.kmginternational.com](http://www.kmginternational.com) and then stored in the Company's internal archive for the duration of the legitimate interest of the Company or until your consent is withdrawn, whichever comes first.

**The Processor /Receiver/ Affiliated Operator** - DCP may be processed by the following persons in strict compliance with the personal data protection legislation:

Companies in the KMG International Group that provide activities to the Company or to which the Company reports its performance (KMG Rompetrol Services Center)

The related services provider Webstyler SRL and / or the archive, any entity with which the Company will contract services and goods and have taken appropriate protection measures as well as other service providers that have concluded contracts with the Company and who are the operator associated according to art. 26 of the RGDP.

**Using DCP** - to give you access to the "Photo Gallery" menu following your registration via the [www.kmginternational.com](http://www.kmginternational.com), to convey your request to our IT service provider WebStyler SRL and to archive your request and information about the downloaded materials. There is a possibility that DCP can be accessed, viewed from anywhere, by third parties.

The company will take all necessary technical and legal measures to protect DCP.

## **1. Rights of the data subject**

In order to be fully informed, you, as the data subject, have the following rights exclusively in respect of your personal rights, pursuant to the EU General Data Protection Regulation:

- a) The right to information and access to your personal data,
- b) The right to have your personal data rectified,
- c) The right to be forgotten/to have your personal data erased;
- d) The right to restriction of processing;
- e) The right to data portability
- f) The right to object to the processing of your data, if your personal data are processed pursuant to point (e) or (f) of Article 6 (1), including profiling based on those provisions, and for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller, and for the purposes of the legitimate interests pursued by the Controller;
- g) The right not to be subject to an individual decision, meaning that you have the right to request and obtain the withdrawal, cancellation and reconsideration of any decision having legal effects on you, adopted solely based on automated data processing for the purpose of evaluating personality traits, such as your professional skills, trustworthiness, behaviour at the workplace;
- h) The right to lodge a complaint with the National Supervisory Authority for Personal Data Processing or to any competent courts.

All these rights may be exercised by a written, signed and dated request to the Data Protection Officer at: [dataprotection@rompetrol.com](mailto:dataprotection@rompetrol.com).

Also, as a data subject, you have the right to contact the National Authority for the Supervision of Personal Data Processing and Justice.

If you submit a request for the exercise of your data protection rights, the Operator will respond to this request within 30 days under the conditions set out in EU Data Protection General Regulation 2016/679.

If you invoke the right to oppose your DCP processing, you will receive a response under art. 21 RGDP, your objection to such an operation, having no effect on the other purposes mentioned in this information.

The Data Controller guarantees that your data are processed for legitimate purposes, and that it implements adequate technical and organizational measures to ensure data integrity and confidentiality pursuant to Articles 25 and 32 of the EU General Data Protection Regulation.
